





African Good Practice Competition on Youth Skills Development and Employment

Are you an organisation that excels in driving good practices on youth skills development and employment promotion on the African continent? If yes, then the African Union Commission and the African Union Development Agency (AUDA-NEPAD) invites you to enter this exciting competition to find, celebrate, and grow the number of good practices across all African countries.

What is the competition about?

The African Skills Portal for Youth Employment and Entrepreneurship (ASPYEE) is a continental knowledge platform hosting a wealth of good practices on Technical, Vocational Education and Training (TVET), skills development methodologies and approaches, and youth employment and entrepreneurship interventions.

This competition aims to increase good practices from all regions, with a focus on regions that are currently under-represented on ASPYEE. These include West, Central, and Northern Africa and conflict-ridden countries.



What can you win?

Five organisations, one from each **African region**, will win:



An **all-expenses paid study tour** to **South Africa**, including all travel, accommodation, and meals! The study tour programme consists of:

- A meet-and-greet with senior officials of AUDA-NEPAD
- A one-day workshop where winning organisations can exchange information, share experiences, and be inspired by their peers from other parts of the continent.
- Field visits to South African trail-blazing organisations, government-led projects, and multistakeholder interventions



Free profiling and marketing, including:


- Being featured on the ASPYEE platform and AU and AUDA-NEPAD social media channels
- A certificate of recognition from AUDA-NEPAD
- Invitations to speak at high-level events

Organisations that have not been selected as winners will still be given an opportunity to share their good practice on ASPYEE if they meet the judging criteria below.

What are the judging criteria?

Demonstrate impact through number of beneficiaries and notable throughput rate, from training to employment

Demonstrate tailored responses to challenges particular to the local conditions



Indicate mechanisms to enable long-term sustainability and alignment of the programme to the local skills and employment system needs

Demonstrate inclusivity of vulnerable groups, including women, youth with disabilities, and youth in conflict-ridden societies

Who qualifies to enter?

- Representatives working at any of these organisations:
 - Colleges (public and private),
 - Non-profit organisations,
 - Training providers,
 - Private sector organisations,
 - Government departments, and
 - Multi-stakeholder led projects
- Practitioners in TVET, youth skills development, employment, and entrepreneurship promotion on the African continent

Note: Interventions targeting youth with disabilities or disadvantaged youth are encouraged.

What is the submission process?



Visit ASPYEE to access the submission form (Link)



Write up your good practice using the template (800 words) and submit before the closing date.

Submissions must be made online, in English, French and Portuguese.



Organisations with existing good practices on ASPYEE may enter the competition, but must still **complete** the application form.

The organisation may use the opportunity to update the existing good practice with up-to-date information.



The competition is **open** from **18 July** and **closes** on **12 August 2022, 23:59 (GMT+3).** Early submissions are encouraged.
